

**PARTICIPATION ADDENDUM to CONTRACT NO. 06332 BETWEEN  
WRIGHT EXPRESS FINANCIAL SERVICES CORPORATION and

A. Definitions:

Contracting Agency agrees to be bound by the terms and conditions of the Agreement, including, without limitation, rules for authorized and unauthorized use of cards, disputes of charges, reporting lost and stolen cards, and all other rules and provisions relating to use of Contracting Agency's account.
